02.05 Continuous Evaluation and Methodology – ODL Programs

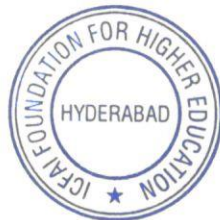
Committee approved the process of continuous evaluation.
